The candidate is directed to produce the following documents IN ORGINAL at the time of counseling for UG courses:

- 1. One stamp **size photo** of the candidate.
- 2. Print out of **allotment memo** downloaded from the application portal.
- 3. KEAM Score card for B Pharm candidates.
- 4. Printout of application form.
- 5. Secondary School Leaving Certificate (SSLC) to prove Age and Date of Birth.
- 6. Certificate and all mark lists (**Plus Two**) of the qualifying Examination.
- 7. Migration certificate
- 8. Transfer certificate and Conduct certificate from the institution where the candidate last studied. If the candidate is studying elsewhere, TC may be produced after confirmation of admission.
- 9. **Caste Certificate** in the case of candidates claiming communal reservation for **SC/ST** issued within one year by the Village Officer/Thahasildar concerned.
- 10. Caste, Income, and Non-creamy layer certificate from the competent authority in the case of candidates belonging to OBH, OBX, Kudumbi, Dheevara, Kusava communities and Non-creamy layer certificate in the case of Viswakarma, Muslim, Ezhava/Thiyya, LC/Anglo Indian communities issued within six months by Thahasildar/Village officer.
- 11. "Income and Assets Certificate to be produced by Economically Weaker Section (EWSs) in General Category" issued by Thahasildar/Village officer should be produced by the candidates claiming Reservation under Economically Weaker Section category.
- 12. Original **Discharge Certificate** issued from the competent authority and certificate form **Zilla Sainik Welfare Board** in the case of candidates claiming reservation under **Ex-servicemen Ouota**.
- 13. Nativity Certificate in the case of candidates claiming Regional Weightage, issued by Thahasildar/Village officer within six months.
- 14. Original NSS/NCC certificate, if applicable. (NCC 'B' Certificate)
- 15. **Medical Fitness Certificate** from a Medical Officer not below the rank of a civil surgeon.
- 16.NRI candidate should submit sponsorship certificate, copy of passport and Employment Certificate attested by the consulate/Embassy at the time of admission. Certificate to prove relationship with the student issued by the village officer also should be submitted

- 17. Certificate issued by Principal/Head of the Institution where the candidate last attended showing whether the candidate has availed fee concession during the academic year, in the case of candidates belonging to SC/ST/OEC category.
- 18. Any other certificate not mentioned above but is relevant for admission to the course applied for.

The selected candidate has to remit the first installment of Tuition Fee and other fees (first half year tuition fee + special fee+ caution deposit) as detailed in the admission prospectus 2020-21 (available at www.cpas.ac.in) or as decided by LBS/CEE on the same day of admission itself, through SB collect link available in the website, failing which their chances for admission will be lost.

Candidates are requested to keep enough attested copies of their certificates for their own future use. Originals once submitted to the institution will be returned only on completion or discontinuation of the course/Programme.
